The Shaler Area School District is now accepting applications for the summer employment program for students residing in the school district. Summer employees work with the regular staff to accomplish these tasks. Employment requirements are:

- Applicants must be a resident of Shaler Area and currently enrolled in school, high school or post-secondary education.
- Applicants must be 15 years of age prior to beginning work or by June 2, 2025.
- Work hours are 8:00 a.m. to 2:30 p.m., Monday through Friday. Work hours include ¹/₂ hour unpaid lunch.
- Compensation: \$11.25/hour. (\$11.75 for returning workers)
